- It may present the orange color variant, composition: 93% meta-aramid, 5% para-aramid and 2% antistatic + 100% Lenzing® mesh (internal face) with an approximate weight of 205 g/m²
- It may present the khaki color variant, composition: 93% meta-aramid, 5% para-aramid and 2% antistatic with an approximate weight of 220 g/m²
- It may present the blue, yellow, green, red and orange color variant, composition: 93% meta-aramid, 5% para-aramid and 2% antistatic + 100% Lenzing® mesh (internal face) with an approximate weight of 220 g/m²

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.

The CAT. III PPE shall only be used in conjunction with one of the conformity assessment procedures according to module C2 or module D described in article 19 letter c) of the Regulation (EU) 2016/425.
